New book on minority rights in Bulgaria

Author: Rechel, Bernd

Title: The Long Way Back to Europe: Minority Protection in Bulgaria (Series on Soviet and Post-Soviet Politics & Society, Vol. 79, edited by Andreas Umland). 362 p. Paperback. 2008. ISBN 978-3-89821-863-4. ISSN 1614-

Topic: By charting minority rights policies in Bulgaria in the period between 1989 and 2004, this study clarifies the main reasons for the limited progress in the post-communist period. While, in contrast to some other countries in Central and Eastern Europe, minority "kin-states" did not play a major role in post-communist Bulgaria, the European Union and the Council of Europe were instrumental in putting minority questions on the agenda of Bulgarian governments. However, their impact was smaller than much of the literature on enlargement and conditionality would suggest. Domestic factors were crucial in shaping minority rights policies in post-communist Bulgaria. Of particular importance was the communist legacy, which acted as a brake on the development of minority rights. The book can be bought via

Topics: The discussion of the first workshop will be continued and intensified with regard the effects of transregional collaboration: e.g. the variety of subjects of collaboration, employment and cross-border migration, joint initiatives for economic development and innovation or attracting investment, joint activities beyond EUfunding, and of course collaboration with non-neighbouring regions.
